Dear Parent,

This letter and accompanying form is for 9-12 grade campers. The High Ropes Challenge Course is designed to help the campers push their own limits in a unique and exciting way. Above all, we strive to create a safe, positive, encouraging, and accepting environment where the attempt is the first and most important measure of success.

The goal of the activity is to allow the participants to step outside of their comfort zone and expand their horizons. Each element provides physical, mental, and emotional challenges. The elements include: two climbing walls, two high traverses, a zip line, and a “jump platform”. These activities teach trust and self-confidence, and help the participant to realize that they are capable of more than they ever thought possible.

Because of the nature of these activities, safety is our first priority. The facility was built with this in mind and all of the involved camp staff members are fully trained and certified. All safety issues (equipment setup and inspection, belaying campers on the climbing walls, traverse elements, and the jump platform, etc.) are handled by the camp staff. Each camper is fitted with a standard climbing harness (a full body harness for the jump platform) and helmet, and is attached to a safety rope at all times. Each safety rope is handled by an assigned staff member who watches, advises, and protects the camper. The campers are given a thorough review of the safety equipment and rules before anything starts, and all harnesses, buckles, and ropes are checked thoroughly before a camper starts any of the elements.

Access is limited so participants are selected randomly from grades 9-12. All participants must have a completed waiver with a parental signature. Campers over 18 years of age can complete and sign their own waivers. A waiver form is on the next page (Page 2 of 2).

If you would like your child to participate, please complete and sign the waiver form and **bring to Camp**. The waiver form is designed so that you can type in your information. (1<sup>st</sup>) Save the blank form on your computer. (2<sup>nd</sup>) Open the form in Adobe Reader. (Free Adobe Reader at: <http://get.adobe.com/reader/?promoid=DJDVP>) (3<sup>rd</sup>) Enter all the information and save it. Then check it to see that the information has been saved in the form. (4<sup>th</sup>) **Bring the signed form to Camp and give it to your Cabin Counselor. No one participates without this signed waiver form.**

Every year this activity is a highlight for many campers who are astonished by what they are able to do. I hope that your child will be able to join us on this adventure.
